Until November 7, the Government of Alberta is seeking public input into a 'made in Alberta' nature strategy that will guide how it maintains, conserves and sustainably manages nature in the province for years to come.

The nature strategy survey responses also have the potential to encourage leadership with conservation efforts — much like the province has done with the successful wildlife crossings already in place and being planned for.

- Access to iconic natural places to recreate, rejuvenate, find peace of mind, and experience remarkable fish and wildlife.
- A healthy nature-based economy both at the province and local level, and,
- Clean, plentiful supplies of water.

- Intact nature is one of the best ways to mitigate harmful impacts of climate change.
- Intact nature supports healthy wetlands and floodplains that naturally store water when we need it most. Healthy nature prevents harmful flooding and provides clean and plentiful water during drier seasons and drought.
- Healthy forests can help mitigate devastating wildfires as well. Intact nature means fires burn more frequently but less severely; and healthy wetlands provide wet, green buffers that can slow fires and protect our mountain communities and air quality.


Y2Y checked "Agree" for statements 1 and 2 and suggests "Neutral" for statement 3 because the answer depends on how these working lands are managed.

Meaningful, respectful engagement with Indigenous Peoples, including involvement in the development and implementation of Alberta's nature strategy, and support for Indigenous-led conservation and co-management, should be at the forefront. Y2Y also believes that Alberta should adopt the UN Declaration on the Rights of Indigenous Peoples (UNDRIP) and approach land planning accordingly.




Y2Y checked" Agree" for all three statements, if managed primarily for conservation, a nature-based economy, that also values intact nature, can be a strong and sustainable one.

The province can help support partnerships and collaborations by including in their nature strategy a commitment to managing lands on the Eastern Slopes for conservation; providing a pathway to protection for special places; halting mining and logging where it doesn't belong; incentivizing community co-existence with wildlife; and working with partners to better plan for and support responsible tourism, development and recreation.

However, we think there is one tool that is clearly missing here and that is the option to support the **protection** of new lands and waters.

Albertans care deeply about their mountains. Continued efforts to protect the most fragile and wonderous places within our Rocky Mountains is key if we are to ensure that these places will be there for generations to come. Not to mention protecting key areas will also safeguard critical headwaters that are increasingly vital for Albertans and other provinces that rely on our cool, mountain waters.

Further, following the lead of Indigenous Peoples, we can explore and designate Indigenous-led protected areas, including Indigenous Protected and Conserved Areas (IPCAs), and support Indigenous Guardian programs on protected and unprotected public lands in Alberta.

Let's call on the province to show us a plan for protecting our natural heritage. Y2Y would check all of them!

Y2Y likes all these options except for "trading nature/ biodiversity credits" as that approach needs more research and development and is still untested.

When it comes to other important actions for a nature strategy, we believe that the province should:

- Provide a pathway to protection of more lands, including through Indigenous-led efforts.
- Manage lands west of the Forest Trunk Road primarily for conservation and halt coal mining on the Eastern Slopes.
- Protect all our critical headwaters.
- Engage in sustainable and responsible tourism and development that avoids important wildlife migration corridors, among other things.
- Support responsible recreation.
- Support and funds programs that help communities and wildlife coexist.

Our perspective

Under "other" we would let the Alberta Government know how proud we are that Alberta is seen as a leader, around the world, in wildlife crossings. Specifically, the wildlife crossings in Banff National Park are seen as the gold standard for effectively keeping wildlife and people safe on our major roads.

With that legacy, Alberta is now showing real leadership in building more highway overpasses and underpasses for wildlife. These structures with fencing help minimize wildlife-vehicle collisions, keeping motorists safe and helping animals move across the land in the way they need to survive and thrive. Everyone gets to where they are going safely! Let's tell them to keep up the good work here and continue to lead!

However, the Alberta Government can also lead in the areas identified in question 16, all of which are vital to improve the protection of nature for Albertans today and in the future. We suggest all are essential components to Alberta's nature strategy and much more work is needed to see progress, including solid plans supported by long-term, sustainable funding.
